# Examining Hans Remoret's corpse (the first time)

The body's temperature indicates that death occurred around 6:30 pm. He was shot twice from behind. The first bullet hit the shoulder area, the second bullet was the fatal shot, as it went through him and exited around his abdomen. It presumably hit a vital organ. Slight trails of blood on the floor lead you to believe that either Hans' body was moved slightly, or he wasn't killed right away, and tried to reach the door to call for help. One bullet was extracted from the body.

# Examining Hans Remoret's corpse (the second time)

A more in-depth examination of the corpse allows you to spot details which you may not have noticed at first glance. First, you notice that the collar of Hans' shirt is stained with blood. You conclude that he must not have closed his gown properly during an operation and that the blood of a patient must've soiled it. You also note that Hans is not wearing a wedding ring. Add that to the fact that he has no identification on him, although it is quite possible that the killer stole all of his personal belongings... Is it a base crime, or simply what someone wants people to believe?

## **Examining Hans Remoret's tattoo**

You examine the dead man's right shoulder, hoping to find trace of a tattoo. Unfortunately, one of the bullets just so happens to have hit him at about that height. If there was a tattoo, there's a good chance it was eliminated by the wound...

# **Examining Hans Remoret's ring finger**

It seems that Hans' ring finger shows no visible trace of a wedding ring. On the other hand, a number of surgeons do not wear their rings when they must perform operations... Maybe Hans only wore it outside his workplace...

#### The corridor

#### Clue 1

You notice that the only way out of the emergency ward is blocked by a large armoire. Surely the hostage takers were the ones who pushed it over to keep the police from coming in...

#### Clue 2

Near the overturned armoire blocking the emergency ward's exit, you find a handful of empty gun casings, and, upon looking at the rifling on them, one bullet!

### **Drake Remoret's locker**

#### Clue 1

You find a number of complex medical texts on the subject of organ transplants. Apparently, Dr. Drake Remoret is very interested in the subject...

#### Clue 2

You find an order form for male hormones, which are used, among other things, to cure severe impotence. Would Drake have trouble on that front?

You find an ultrasound. A fetus about to reach term is clearly seen on it. The name of the patient who underwent the ultrasound is Gail Remoret.

#### Clue 4

You find a copy of a life insurance contract, which states that if Hans ever died, Gail Remoret, Drake Remoret, and Brighton hospital would split a sum of 6 million dollars between them.

### Hans Remoret's locker

#### Clue 1

You find this message:

"Dr. Hans Remoret,

I would like to speak with you regarding something which would be of interest to you...

I will be at the hospital until early evening.

Reverend Tom"

#### Clue 2

You find Dr. Hans Remoret's agenda/appointment book. Leafing through it, you notice that Hans was summoned before judge Dawson for next Tuesday. Was this about a medical case?

## **Gail Remoret's purse**

#### Clue 1

You find a copy of last month's "Life in Detroit". Leafing through it, you see that an entire article is about Gail. It is particularly laudatory and talks about how Gail brilliantly managed to balance her career in law and her family life. You also find a lighter.

#### Clue 2

You find a letter:

"Gail, my love,

Let's meet tomorrow night at my place.

I'll be leaving the hospital around 7pm and Hans will be on duty.

I love you."

#### Clue 3

You find a copy of a life insurance contract, which states that if Hans ever died, Gail Remoret, Drake Remoret, and Brighton hospital would split a sum of 6 million dollars between them.

## **Administrator Berkeley's briefcase**

#### Clue 1

Between a Rolex and the keys to a Lamborghini is a laptop which can connect to the internet when a cell phone is connected to the computer.

#### Clue 2

You find a medical book on the topic of organ transplants. Administrator Berkeley has obviously made a lot of notes throughout the book...

#### Clue 3

You find a copy of a life insurance contract, which states that if Hans ever died, Gail Remoret, Drake Remoret and Brighton hospital would split the sum of 6 million dollars between them.

#### Clue 4

The briefcase has a fake bottom: you find \$25,000 cash hidden in it!

## Intern Carter's locker

#### Clue 1

You find a medical handbook titled: "The basics of emergency medicine". A bookmark is placed at the beginning of the "Organ removal and transplant" chapter.

#### Clue 2

You find what looks to you like some sort of grocery list. After looking at it more attentively, you realize it's a list of organs, all different. The common point between these organs is that they are those for which demand is highest from hospitals who use them to save human lives...

#### Clue 3

You find a police badge.

## Hostage takers' bag

#### Clue 1

You find a plan of the hospital's 6th floor. The central laboratory, along with the computer core, is on that floor.

#### Clue 2

You find a bible autographed by Reverend Tom. May my voice lead you on the right path...
Tom »

#### Clue 3

You find a scientific file containing a massive amount of formulae and experiment results. The file is about the creation of a cyclosporine derivative which would put an end to rejections during organ transplants.

# Examination room 4: Reverend Tom's room

#### Clue 1

You find Dr. Drake Remoret's business card.

#### Clue 2

You find the material required to make an injection (syringe, cotton swab...). Apparently, a doctor was about to tend to someone in this room.

### Clue 3

You find a picture of the televangelist. He is posing next to an obviously brand-new Ferrari. However, looking more closely at the picture, you notice a bump on the front of the car's hood...

#### Clue 4

In the televangelist's bag, you find a little address book. It is filled with surprising phone numbers such as: "Cindy: 555-2332 or Vanessa: 555-6236..."

### Dr. Parlowski's locker

#### Clue 1

You find a picture of a young man who looks very much like Dr. Parlowski. It most probably is his son.

#### Clue 2

You find a report on Carter written by Dr. Parlowski. His review is catastrophic, as in his conclusion, Dr. Parlowski states that Carter does not deserve to wear a doctor's gown.

#### Clue 3

You find an article from "surgeon magazine":

"Dr. Hans Remoret, first doctor at Brighton? One can only wonder if the Parlowski era is over. Upon seeing the excellent results from Dr. Hans Remoret, who, for those who have been living in a cave, happens to be an urgentologist, some already see in him THE next great American surgeon of the decade. In any case, one must admit that Dr. Remoret does possess a perfect mastery of surgical instruments. And while some observers claim that Dr. Parlowski's level has been slowly diminishing lately, Hans Remoret, on the other hand, surprises more and more. His interventions are remarkable and he is becoming faster without losing the slightest precision. Is Parlowski's supremacy at Brighton hospital about to crumble?"

#### Clue 4

You find an Alcoholics Anonymous card.

### **Head nurse Costa's locker**

#### Clue 1

You find this letter:

"From: Dr. Hanspoe, head of staff Intensive care

To: Head Nurse Costa

This letter is to inform you of your mother's transfer to our intensive care service. Her sclerosis will now require very specific care and a constant attention. I would like you to get in touch with me again so that we can talk about the payment for the hospital stay.

Dr. Hanspoe."

#### Clue 2

You find a letter:

"United Bank of Detroit

Mr./Ms. Costa,

I'm sorry to inform you that your request for a loan has been turned down.

Reason: insufficient guarantees."

#### Clue 3

You find an old newspaper article:

"October 12th 1997

The Cath case: nurse acquitted

In the Cath case which pitted a patient (Robert Cath) against Head Nurse Costa of Brighton hospital's emergency service, Costa's innocence was proven by his/her lawyer, Gail Remoret. The nurse will therefore keep on working at the emergency service."

#### Clue 4

You find a thick steel box. Inside are a few scalpels, some jars and physiological liquid.

### The crime scene

#### Clue 1

You notice that a security camera is in a corner of the laboratory. It would be too nice, but maybe it caught the murder as it happened?

#### Clue 2

On the blackboard, you find a number of highly complex chemical formulae written, along with the following note:

"Very important: Do not erase.

Dr. Drake Remoret."

#### Clue 3

On a mat, you find a cage holding a lab rat. It is entirely white, with the exception of a patch on its back where long black hairs have grown. Skin from a different rat was probably grafted on to it. From where the cage is, the rat must've seen the entire murder. If only it could speak...

## The security room

You notice that today's surveillance tapes are no longer in the recording machines, but were burnt in the trashcan in the room's corner. Moreover, according to a status report from the computer in charge of the security cameras, you learn that the system was shut down at 6:32 pm.

### The medical files

#### Scott Parlowski's file

Important remark to the intention of people reading this medical file.

These files are covered by medical confidentiality: their contents must therefore not be given to people outside of the hospital's staff.

He was Dr. Hans Remoret's patient. He was also Dr. Parlowski's son. The patient had been admitted to the emergency after a motorcycle accident. He had died a few minutes later. Dr. Hans Remoret had done all he could to save the young man, but his attempts proved useless.

#### Jim Mason's file

Important remark to the intention of people reading this medical file.

These files are covered by medical confidentiality: their contents must therefore not be given to people outside of the hospital's staff.

He was Dr. Hans Remoret's patient. He had been admitted seven months ago after a traffic accident, which had seriously wounded his abdomen. With the assistance of Head Nurse Costa, Dr. Hans Remoret was able to save the young man, but had to remove one of his kidneys. Jim Mason sued both the hospital and Dr. Hans Remoret afterwards. The hospital was absolved of any responsibility. After a more thorough study of the case, you realize that, indeed, the removal of Jim Mason's kidney by Dr. Hans Remoret was needless.

#### Eric Lea's file

Important remark to the intention of people reading this medical file.

These files are covered by medical confidentiality: their contents must therefore not be given to people outside of the hospital's staff.

He was Dr. Drake Remoret's patient. The file is incomplete as the patient was admitted this afternoon, at around 5pm. He had a javelin stuck in his abdomen. Drake Remoret, assisted by Head Nurse Costa and Intern Carter saved him.

#### Robert Cath's file

Important remark to the intention of people reading this medical file.

These files are covered by medical confidentiality: their contents must therefore not be given to people outside of the hospital's staff.

He was a patient of Dr. Morgenstern (who is off on vacation at this moment). He was admitted due to severe pains in his lower abdomen. Dr. Morgenstern required a series of examinations. Head Nurse Costa was asked to inject a radioactive isotope near his spleen. The patient reacted badly and was paralyzed. Cath sued the hospital and Head Nurse Costa. Gail Remoret took up the nurse's defense. Cath accused Costa of having made two injections instead of one (the second one having caused paralysis). But that allegation was unproven, and Cath was actually allergic to the isotope (which could not have been foreseen, due to his sparse medical record), so Costa was acquitted.

### Reverend Tom's file

This patient is under Dr. Drake Remoret's care, but he has yet to enter any information about him in the hospital's computer system.

# Fake file for intern Carter N° BBD342/L09

# Important note regarding guns and bullets

Only Intern Carter knows which bullet comes from which gun. Showing him/her the various guns found at the hospital tonight (the one in administrator Berkeley's possession and the one held by the hostage taker), as well as the bullets found in the corridor or extracted from the corpse of the dead man will allow a player (without spending APs) to get the following information:

## **Bullet extracted from the victim's corpse:** .38 special

## Bullet found in the corridor:

.44 Magnum

#### Hostage taker's weapon:

.44 Magnum

## Weapon in administrator Berkeley's possession:

.38 spécial

All clues which have the " before their description are available in the box as handout clues to be given directly to the players.

# Drake Remoret's first clue

As you were talking with your colleagues at the cafeteria (right before Hans' death was announced), you horribly realized that you were still wearing your wedding ring. You forgot to slip it onto your brother's finger. Discreetly, you slip it in your own pocket...

# Gail Remoret's first clue

Before going into the cafeteria, you've decided to be prudent and went to burn the surveillance videotapes in the security room. No one saw you. Now, you are sure that no one will ever see a recording of the crime...

# Intern Carter's first clue

When Berkeley entered the emergency section today, he looked to you as though he was headed your way to talk to you. But whether it was it the presence of your colleagues or a sudden change of heart, he ended up not telling you a thing. Was it just an impression or did he really have something to tell you?

# Administrator Berkeley's first clue

In the briefcase you took with you to the emergency room, you have \$25,000 cash (hidden in a fake bottom). You intended to contact your thieves tonight and give it to them in exchange for the file you so coveted. But if the hostage takers are your thieves and they get caught, this cash will no longer be useful... You really have to learn who they are and eventually do the trade before it is too late...

# Tony Biagelli's first clue

You checked to see how many bullets you had after having barred the door to the emergency room using an armoire. You had two left and got rid of the empty casings by tossing them on the floor. Thing is, you just checked again and realized that you only have one bullet left in your gun! In your hurry, you must have tossed the other bullet with the casings...

# Reverend Tom's first clue

As you were resting in examination room 4, you saw a car park in the hospital's lot. It was about 6:30 pm. A beautiful woman, pregnant, came out – it was of course Gail Remoret. A few minutes later, Gail went back to her car. You didn't pay attention to what she was doing on the parking lot, but now you're wondering...

# Head Nurse Costa's first clue

You remember that one day you saw Dr. Parlowski come out of a psychiatrist's office downtown. You hadn't known at the time that the surgeon was seeing a therapist and, quite honestly, you paid it no mind. But now that there's been a death today, you've been wondering — do you think he could be psychologically unstable to the point of committing murder?

# Dr. Parlowski's first clue

When Reverend Tom got to the hospital today, he went up to you to talk a bit, and then asked if Dr. Hans Remoret was on duty today. You answered that he was. This rather banal conversation now takes on a completely different meaning when you consider that Hans was killed tonight...
